

# Building a community of practice

The first decade of our story has centred on connecting people who have curiosity for how research can help them do their jobs in better ways. Our flagship event is a national conference, which has been connecting police officers and staff with academics, businesses, and charities from around the world since 2012. The connections made and the knowledge gained at these events make a real difference.

85%

In 2025, our online Member's Hub began to connect our members to each other and to our suite of up to date resources on a daily basis.

# Evidence Based Policing in action

The question was, "Could we improve our service to domestic abuse victims by providing an optional immediate video response from a specially trained police officer rather than scheduling a delayed face-to-face police visit?"



Modern policing is full of problems.

One is being able to give victims the service they need promptly.

Call volumes are rising and cases are getting more complex. This was the challenge

Eastern Region Innovation Network manager Stacey Rothwell took on in.

Stacey's proposal was controversial. Guidelines call for officers to attend some types of call in all cases. There was concern about what might happen if an officer didn't go. Would victims in these cases be less happy with the serve?

Research provided some answers.


Stacey led a randomised experiment where some non-emergency callers received an immediate appointment with a police officer via online video and others got the usual service. The results told their own story.



11% higher victim satisfaction



Time to see an officer down from 33 hours to just **3 minutes** 




83 minutes officer time saved per case


